EXECUTIVE ORDER NO. 008- 2020

CREATING TASK FORCE COVID-19 IN THE MUNICIPALITY OF PORAC

WHEREAS, Presidential Proclamation No. 922 signed by President Duterte on 08 March 2020 "DECLARING A STATE OF PUBLIC HEALTH EMERGENCY THROUGHOUT THE PHILIPPINES" amid DOH Secretary has confirmed the local transmission of Corona Virus Disease (Covid-19) in the Philippines;

WHEREAS, the declaration of a State of Public Health Emergency would capacitate government agencies and LGUs to immediately act to prevent loss of life, utilize appropriate resources to implement urgent and critical measures to contain or prevent the spread of Covid-19, mitigate its effects and impact to the community and prevent serious disruption of the functioning of the government and the community;

WHEREAS, all government agencies and LGUs are hereby enjoined to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner to curtail and eliminate the Covid-19 threat;

NOW, THEREFORE, I, JAIME V. CAPIL, Municipal Mayor of Porac, Pampanga, by virtue of the powers vested in me by law, do hereby order:


Section 2. Duties and Functions of Task Force Covid-19.

- a. Formulate policies and guidelines in the procurement and disbursement for Covid-19 related plans and operation necessities;
- b. Validate and disseminate information through designated spokesperson to avoid misinformation or fake news;
- c. Evaluate information and directives from higher authorities for its proper implementation;
- d. Perform other duties and functions as may be provided by law, statute or ordinance.

Section 3. Meetings. Conduct meetings whenever deemed necessary.

Section 4. Effectivity. This Order shall take effect immediately.
