EXECUTIVE ORDER NO. 10-2020

AN ORDER DECLARING THIRTY (30) DAYS COMMUNITY QUARANTINE IN THE MUNICIPALITY OF PORAC FROM MARCH 16, 2020 TO APRIL 14, 2020 FOR THE MANAGEMENT OF THE SPREAD OF CORONA VIRUS DISEASE (COVID-19).

WHEREAS, President Duterte issued Proclamation 922 on March 8, 2020, declaring a State of Public Health Emergency;

WHEREAS, all government agencies and LGUs are hereby enjoined to render full assistance and cooperation and mobilize the necessary resources to undertake, critical, urgent, and appropriate response and measures in a timely manner to curtail and eliminate the Covid-19 threat;

WHEREAS, upon confirmation of Department of Health Regional Office III, there is a confirmed positive case of COVID 19 residing at Porac, Pampanga;

WHEREAS, the Municipal Health Office reported that there are increasing cases of Person under Investigation (PUI) and Persons under Monitoring (PUM);

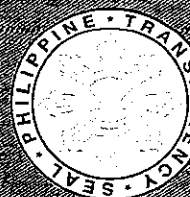
WHEREAS, upon the recommendation of the Porac Covid 19 Task Force through its Resolution No. 2 series of 2020, actions shall be taken to fight the spread of CO-VID 19;

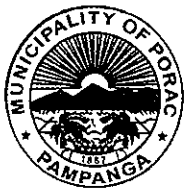
NOW, THEREFORE, I, JAIME V. CAPIL, Municipal Mayor of Porac, Pampanga, by the power vested in me by law, do hereby order:

Section 1. Thirty (30) Days Quarantine in the Municipality, commencing on March 16, 2020 and ending on April 14, 2020;

Section 2. Everyone should stay in their respective homes/residences except on the following instances:

- a. To work;
- b. To buy food, medicines and other urgent necessities;
- c. To seek medical attention; and
- d. Other analogous emergency situations

Section 3. Classes in all levels, public and private institutions shall be suspended until further notice;

Section 4. Mass gatherings are strongly discouraged. In exceptional cases, social distancing must be strictly observed (i.e one meter apart from one another);

Section 5. Government offices shall observe rotational schedule in compliance with the Civil Service Guidelines on 4-day work week for individuals;

Section 6. Philippine National Police with the assistance of barangay force multipliers, if necessary, shall conduct screening procedures to persons coming from other municipalities, cities, and/or provinces before entry;

Section 7. Private offices/establishments are encouraged to prepare and implement flexible work plan for their employees;

Section 8. Public transportation will be allowed but social distancing and sanitation protocol must be strictly observed;

Section 9. All other activities may be regulated in accordance with the community quarantine.

The Municipality of Porac shall maintain open and transparent plans and programs in relation to COVID-19. These shall be effective upon signing of this Executive Order and shall be reviewed and updated every two weeks or as often as necessary.
