EXECUTIVE ORDER NO. 012- 2020

AN ORDER ADOPTING GUIDELINES FOR THE OPERATION OF THE PORAC PUBLIC MARKETS, TALIPAPA (TEMPORARY MARKET) AND BUSINESSES TAGGED AS ESSENTIAL ESTABLISHMENTS UNTIL THE ENHANCED COMMUNITY QUARANTINE IS LIFTED

WHEREAS, Presidential Proclamation No. 922 signed by President Duterte on 08 March 2020 "DECLARING A STATE OF PUBLIC HEALTH EMERGENCY THROUGHOUT THE PHILIPPINES" amid DOH Secretary has confirmed the local transmission of Corona Virus Disease (Covid-19) in the Philippines;

WHEREAS, the declaration of a State of Public Health Emergency would capacitate government agencies and LGUs to immediately act to prevent loss of life, utilize appropriate resources to implement urgent and critical measures to contain or prevent the spread of Covid-19, mitigate its effects and impact to the community and prevent serious disruption of the functioning of the government and the community;

WHEREAS, all government agencies and LGUs are hereby enjoined to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner to curtail and eliminate the Covid-19 threat;

NOW, THEREFORE, I, JAIME V. CAPIL, Municipal Mayor of Porac, Pampanga, by virtue of the powers vested in me by law, do hereby order to implement the following guidelines for the operation of the Porac Public Markets, Talipapa and similar establishments:

Section 1 **Operating Hours**

Daily market hours is from 5:00 A.M. to 12:00 NN only. No one is allowed to stay in the Public Market beyond the market hours without authorization from the Market Supervisor;

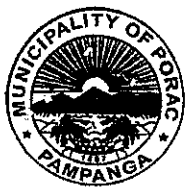
Section 2 **Face Mask**

All individuals entering the premises of the public market must wear face mask at all times as well as the sellers/vendors;

Section 3 **Barangay Talipapa (Temporary Market)**

Each barangay, if within its capacity, must put up Talipapa or Temporary Market subject to the approval of the Porac Task Force Covid19. Talipapa must observe guidelines as with the Public Market under Sections 1, 2 and 4.

Section 4 Social distancing must be strictly observed in the market premises;

MUNICIPALITY OF PORAC





Section 5 Businesses tagged as essential establishments in Porac such as sari sari stores, mini-groceries, bakeries, supermarkets, convenience stores, eatery, carideria and other authorized businesses must follow safety precautions such as the following:

- a) Operating hours must be within the 5am-8pm curfew
- b) Social distancing within the store's premises
- c) Providing alcohol or disinfectant to all entering the store/shop

Section 6. Effectivity. This Order shall take effect immediately.
