**EXECUTIVE ORDER NO. 015-2020**

**AN ORDER REGULATING THE OPERATION OF THE PORAC PUBLIC MARKETS, TALIPAPA (TEMPORARY MARKET) AND BUSINESSES TAGGED AS ESSENTIAL ESTABLISHMENTS UNTIL THE ENHANCED COMMUNITY QUARANTINE IS LIFTED**

**WHEREAS**, Presidential Proclamation No. 922 signed by President Duterte on 08 March 2020 "DECLARING A STATE OF PUBLIC HEALTH EMERGENCY THROUGHOUT THE PHILIPPINES" amid DOH Secretary has confirmed the local transmission of Corona Virus Disease (Covid-19) in the Philippines;

**WHEREAS**, the declaration of a State of Public Health Emergency would capacitate government agencies and LGUs to immediately act to prevent loss of life, utilize appropriate resources to implement urgent and critical measures to contain or prevent the spread of Covid-19, mitigate its effects and impact to the community and prevent serious disruption of the functioning of the government and the community;

**WHEREAS**, all government agencies and LGUs are hereby enjoined to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner to curtail and eliminate the Covid-19 threat;

**NOW, THEREFORE**, I, JAIME V. CAPIL, Municipal Mayor of Porac, Pampanga, by virtue of the powers vested in me by law, do hereby order to implement the following guidelines for the operation of the Porac Public Markets, Talipapa and similar establishments:

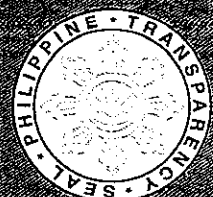
**Section 1 Operating Hours.** Public Markets hours will follow the schedule stated in the Sangguniang Bayan Ordinance in relation to the revised curfew hours;

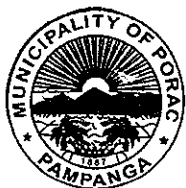
**Section 2 Operating Days.** The schedule of the Public Markets with the respective market days for each barangays is provided below to allow decontamination and sanitation;

<b>Monday &amp; Friday</b>	<b>GROUP 1</b> Planas, Pio & Tokwing, Palat, Jalung, Babo Pangulo, Babo Sacan, Mancatian, Poblacion, Cangatba, Camias, Diaz, Inararo, Sapang Uwak, Villa Maria
<b>Wednesday &amp; Saturday</b>	<b>GROUP 2</b> Sta. Cruz, Manuali, Señura, Manibaug Paralaya, Manibaug Libutad, Manibaug Pasig, Calzadang Bayu, Hacienda Dolores, Pulong Santol, Sepung Bulaon, Balubad, Salu, Pias, Mitla Proper, Mitla San Jose
<b>Tuesday, Thursday &amp; Sunday</b>	<b>CLOSED (For Decontamination &amp; Disinfection)</b> <i>Only delivery of supplies shall be allowed to enter the Public Market Premises</i>

**Section 3 Face Mask**

All individuals, including sellers/vendors, entering the premises of the public market must wear face mask at all times;

**Section 4 Barangay Talipapa (Temporary Market)**

Each barangay must put up Talipapa or Temporary Market subject to the approval of the Porac Task Force Covid19. Talipapa must observe guidelines applicable to public market pertaining to social distancing & other related matters;

**Section 5** Social distancing must be strictly observed in the market premises; the Public Market Supervisor must devise a plan to control the people entering the premises of the market;

**Section 6** Decontamination station must be set-up at the entrance of the public market with the assistance of the Porac BFP and Engineering Office.

**Section 7** Businesses tagged as essential establishments in Porac such as sari-sari stores, mini-groceries, bakeries, supermarkets, convenience stores, eatery, carinderia and other authorized businesses must follow safety precautions such as the following:

- a) Operating hours must be within the curfew
- b) Social distancing within the store's premises
- c) Providing alcohol or disinfectant to all entering the store/shop
- d) Decontamination station must be set-up at the entrance

**Section 8 Repealing Clause.** All issuances inconsistent with the provisions of this order are hereby repealed or amended accordingly;

**Section 9 Effectivity.** This Order shall take effect immediately.
