EXECUTIVE ORDER NO. 017-2020

AN ORDER REPEALING SECTION 2 OF EXECUTIVE ORDER NO. 015-2020 ON REGULATING THE OPERATION OF THE PORAC PUBLIC MARKETS UNTIL THE ENHANCED COMMUNITY QUARANTINE IS LIFTED

WHEREAS, Presidential Proclamation No. 922 signed by President Duterte on 08 March 2020 "DECLARING A STATE OF PUBLIC HEALTH EMERGENCY THROUGHOUT THE PHILIPPINES" as DOH Secretary confirmed the local transmission of Corona Virus Disease (Covid-19) in the Philippines;

WHEREAS, the declaration of a State of Public Health Emergency would capacitate government agencies and LGUs to immediately act to prevent loss of life, utilize appropriate resources to implement urgent and critical measures to contain or prevent the spread of Covid-19, mitigate its effects and impact to the community and prevent serious disruption of the functioning of the government and the community;

WHEREAS, all government agencies and LGUs are hereby enjoined to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner to curtail and eliminate the Covid-19 threat;

NOW, THEREFORE, I, JAIME V. CAPIL, Municipal Mayor, Porac, Pampanga, by virtue of the powers vested in me by law, do hereby order to repeal Section 2 of Executive Order No. 015-2020 to wit:

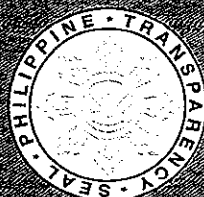
Section 2 of EO No. 015-2020 states that:

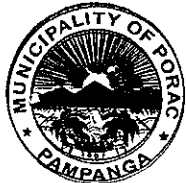
Operating Days. The schedule of the Public Markets with the respective market days for each barangays is provided below to allow decontamination and sanitation;
