**EXECUTIVE ORDER NO. 18 - 2020**

**AN ORDER ESTABLISHING A MUNICIPAL SPECIAL CARE AND ISOLATION FACILITY FOR PUMS, PUIS AND THOSE POSITIVE COVID-19 CASES WITH MILD SYMPTOMS**

**WHEREAS**, in support to the Inter-Agency Task Force on Emerging Infectious Diseases Resolution (IATF-EID) No. 16 directing Local Government Units (LGUs) and Government Owned and Controlled Corporations (GOCCs) to identify government facilities that may be temporarily converted into isolation facilities;

**WHEREAS**, DILG Memorandum Circular No. 2020-064 dated March 29, 2020 mandates all Municipal Mayors to identify special care and isolation units amid COVID-19 pandemic;

**WHEREAS**, this LGU adheres to this mandate and hereby designate the Newly Built Command Center located at Porac National Hi way, Brgy. Jalung as temporary special care and isolation facility;

**NOW THEREFORE, I, JAIME V. CAPIL**, Municipal Mayor of Porac, Pampanga, by virtue of the power vested in me by law do hereby order the following:

**Section 1 – Establishment of Municipal Special Care and Isolation Facility.** It is hereby ordered to convert temporarily the newly built command center located at Brgy. Jalung as temporary special care and isolation facility for PUMs, PUIs and those COVID-19 positive with mild symptoms. Furthermore, the facility must be in accordance with Interim guidelines set by the Department of Health (DOH) Memorandum No. 2020-0123 and Department of Interior and Local Government (DILG) Memorandum Circular No. 2020-064.

**Section 2 – Fund Source.** Expenses that will occur in the set-up and operation of temporary special care and isolation facility will be charged against the MDRRMO fund subject to existing rules and regulations and to the approved supplemental budget for the fight against COVID-19 with Sangguniang Bayan Ordinance No. 08 Series of 2020.

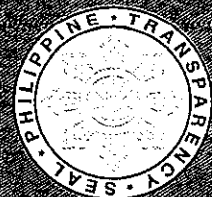
**Section 3 – Staffing.** The Municipal Health Officer will determine the staffing and the trainings they need to undergo in order to be qualified as staff in the said facility.

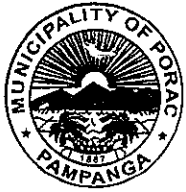
**Section 4 - Security.** The Porac Police Station is in charge of the security of the area to make sure that people undergoing quarantine will follow all the standard procedures. They must provide security to the area 24/7. In case of violation of quarantine measures, appropriate legal actions shall be filed against violator.

**Section 5 – Disinfection.** The Porac Fire Station will be in charge in the disinfection before and after the use of the facility. A disinfection booth must be established at the entrance.

**Section 6 – Transportation.** The MDRRMO shall be responsible for transporting PUMs, PUIs and COVID-19 positive with mild symptoms provided a specific ambulance will only be used and must be disinfected regularly. The driver must wear PPEs at all times.

**Section 7 – Effectivity.** This order shall take effect immediately upon approval.
