**EXECUTIVE ORDER NO. 013- 2017**

**AN ORDER IMPOSING MODIFICATION ON TRAFFIC RULES ALONG THE PORAC-ANGELES ROAD**

**WHEREAS**, the construction of the bridge in Barangay Manibaug Paralaya and reblocking of the road in Barangay Sta. Cruz, Barangay Manibaug Paralaya, and Barangay Manibaug Libutad requires further preparation in the traffic management otherwise it would result inevitably to the escalation of the town's existing and perennial traffic dilemma;

**WHEREAS**, there is an urgent need to modify regulations concerning Municipal Traffic Rules to minimize the anticipated traffic congestion along the Angeles-Porac road, particularly within the stretch from Barangay Sta. Cruz to Manibaug portions and to avert terrible delays on various activities, especially the transport of commuters, goods and services;

**WHEREAS**, the Municipal Mayor, pursuant to section 5 of Municipal Ordinance No. 040-1998, is authorized to issue an Executive Order to modify Municipal Traffic Rules;

**NOW THEREFORE, I, CONDRALITO B. DELA CRUZ**, Municipal Mayor, by virtue of the powers vested in me by law and ordinance, do hereby order the following:

**Section 1.** There is hereby modification on the Traffic Rules and Regulations of the Municipality of Porac (M.O. No. 040-1998), along the Angeles-Porac road through the following provisions:

Except from all delivery trucks carrying perishable goods, food, fuel, farm products (such as feeds and fertilizers), and government vehicles and equipments, all heavy vehicles and equipments such as truck, loaders, buses, back hoes, and among others, shall be prohibited from taking or passing through the Angeles-Porac highway along the stretch from Barangay Sta. Cruz to Manibaug Pasig portion and vice versa, from **6:00 A.M. to 8:30 P.M.** commencing from April 24, 2017.


**Section 2.** The Chief of Police is hereby ordered to draw an efficient traffic management scheme in accordance with this Order, the Municipal Traffic Ordinance and other existing traffic regulations to maintain smooth flows of vehicles along the area. The Chief of Police is further instructed to submit within ten (10) days, a report with appropriate recommendation, if there's any, to the Municipal Mayor, on the consequence after one month of implementation thereof.

**Section 3.** Violators of this Order shall be penalized under the provisions of Municipal Ordinance No. 04-1998;

**Section 4.** This Order is a supplementary regulation to the existing Municipal Traffic Ordinance and shall not however, be construed as an order repealing the latter;

**Section 5.** This Order shall take effect on the 24th day of April 2017 and shall remain in full force unless repealed or modified accordingly by another Order or Ordinance.
