**Municipal Ordinance No. 12
 Series of 2020**

AN ORDINANCE AMENDING SECTION 4 OF MUNICIPAL ORDINANCE NO. 05, SERIES OF 2020, KNOWN AS "PORAC ANTI-COVID-19 CURFEW HOURS ORDINANCE OF 2020," MODIFYING FOR THE PURPOSE, THE IMPOSITION OF PENALTY FOR VIOLATORS OF THE IMPOSED MUNICIPAL-WIDE CURFEW HOURS, AS A MEASURE TO REGULATE CIVILIAN MOVEMENTS TO PREVENT OR CONTROL THE RAPID SPREAD OF CORONA VIRUS DISEASE (COVID-19) IN THE MUNICIPALITY OF PORAC, PAMPANGA

Be it ordained by the Sangguniang Bayan of Porac in session assembled that:

Section 1. Section 4 of Municipal Ordinance No. 05, Series of 2020, known as "Porac Anti-Covid-19 Curfew Hours Ordinance of 2020," is hereby amended to read as:

Section 4. Penalty. Violation hereof is punishable by a mandatory quarantine of Seven (7) days and a fine of Php Five Hundred (500.00) pesos for the first offense; a mandatory quarantine of Fourteen (14) days and a fine of One Thousand Five Hundred (Php 1,500.00) pesos for the second offense; and a mandatory quarantine until the Enhanced Community Quarantine (ECQ) has been lifted by the Philippine President and a fine of Two Thousand Five Hundred (Php 2,500.00) pesos for the third offense.

Section 2. Repealing Clause. Ordinance inconsistent herewith is hereby repealed, amended or modified accordingly. Provided: Nothing in this Ordinance shall be construed as repealing, amending or modifying in any manner the provisions of Municipal Ordinance No. 08, series of 2016, otherwise known as "Curfew Hours for the Protection of Minors Ordinance of 2016."
