AN ORDINANCE AMENDING SECTION 2 OF MUNICIPAL ORDINANCE NO. 09, SERIES OF 2020, OTHERWISE KNOWN AS SUPPLEMENTAL BUDGET NO. 2020-02, MODIFYING AND REALIGNING FOR THE PURPOSE THE EXPENDITURE PROGRAM AND THE FUNDS APPROPRIATED THEREIN, IN RESPONSE TO THE CRISIS RESULTING FROM THE ATTACK OF GLOBAL PANDEMIC CORONA VIRUS DISEASE (COVID-19)

Be it ordained by the Sangguniang Bayan of Porac in session assembled that:

Section 1. This Ordinance shall be known as Amendment to the Supplemental Budget No. 2020-02.

Section 2. Section 2 of Municipal Ordinance No. 09, Series of 2020 is hereby amended to read as:

Section 2. For the government to respond to the emerging crisis resulting from the attack of Global Pandemic Corona Virus Disease (COVID-19), the sum of Twenty-Seven Million Fourteen Thousand Seventeen (Php 27,014,017.00) pesos, is hereby appropriated for the following:

Section 3. The herein appropriated funds shall be utilized for which they are intended to and pursuant to Paragraph No. 3.10 of LBC No. 125, the disbursement and utilization of the BGCM shall be subject to the pertinent provisions of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act and its Implementing Rules and Regulations (IRR), and any relevant policies issued by the Government Procurement Policy Board (GPPB), as well as other applicable laws, and budgeting, accounting and auditing rules and regulations (R.A. No. 7160).

Section 4. Ordinance inconsistent herewith is hereby repealed or modified accordingly.

Section 5. This Ordinance shall take effect immediately upon its approval.
